RECOMMENDATIONS OF THE INSPECTION COMMITTEE :

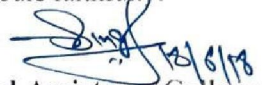
1. The required number of eligible staff (Teaching & Non-teaching) be appointed as per university norms before the commencement of the Academic session 2018-19.

4. The college should have separate labs for zoology and botany.
5. There should be proper ramp for differently abled persons upto 1st Floor of the building.
6. Multipurpose hall should be equipped with necessary appliances/items such as projector screen, furniture, curtains etc.
7. There is requirement of the construction of a well-equipped gymnasium & canteen.
8. There should be sufficient and timely extension of building on yearly basis as per requirement.

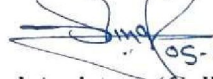
